1 RETIRED MEMBERSHIP

- You have retired from full time employment and your total income excluding any pensions is less than £7,500 per annum.

2 CONCESSIONARY MEMBERSHIP

In applying for the concessionary rate of membership you are confirming that one of the following criteria is applicable to yourself:

- Your earnings are less than £7,500 per annum.
- You have been made redundant by your employer.
- You are currently unemployed or unable to work due to illness.
- You are currently on maternity or paternity leave.

Please note that the concessionary rate must be applied for on an annual basis.

You agree that you will contact CIBSE immediately if your earnings increase above the aforementioned amount or your circumstances change and thus you will revert back to paying the standard subscription rate.
