Provision of lifts, escalators and passenger conveyors in airports

MINUTES

1.0 Welcome and Apologies

2.0 Election of Officers

3.0 Previous Minutes

The minutes of the previous meeting were accepted without alteration.

4.0 Matters Arising

As per agenda.

5.0 Standards and Regulations

Dr Gina Barney gave an overview of the status of current codes and standards as summarised below:

A2-EN81 : *MRLs* has now been agreed and is to be published.

prEN81-21 : *New lifts in existing buildings* is expected soon.

prEN81-22 : *Inclined lifts* is expected soon.

prEN81-40 : *Stairlifts* and prEN81-41 *Lifting platforms* are both in enquiry until 1st March 2005.

prEN81-43 : *Crane lifts* and prEN81-71 *Vandal resistant* are both expected soon.

prEN81-73 : *Behaviour of lifts in the event of fire* has now been agreed and is to be published soon.

BS EN12016 : *EMC Immunity*, BS7801: *Safe working on escalators and moving walks* and BS 5656 Part 2: *Selection installation and location of escalators* were all published in 2004.

BS 5588 Part 5: *Access and facilities for fire-fighting* has been republished in its entirety and the previous version withdrawn.

BS 5588 Part 8: *Code of practice for means of escape for disabled people* is in hand for revision.

BS 5588 Part 12: *Managing fire safety* has been published.

BS 5588 is to eventually be replaced by BS9999.

6.0 Seminars / Presentation

Dr Gina Barney reported on attendance levels at CIBSE Lifts Group events throughout 2004.

Six meetings in total were held in 2004 (2003 – 8) and were attended by a total of 206 people with an average attendance of 34.

At the Annual Seminar, 15 attendees became Affiliate members of CIBSE through the Lift Groups promoted membership scheme.

7.0 CIBSE Lift Group Hong Kong

Albert So reported by e-mail that CIBSE HK held two events last year relating to lifts.

October 2004: supported BETNET group of IEE at a workshop where there were 4 papers presented at the conference on transportation in buildings.

November 2004: Supported IAEE for a workshop on remote monitoring with two guest speakers from Singapore talking about their experience in monitoring 18000 lifts.

Albert So also presented a paper on *Emergency Escape By Lifts* at a joint symposium between CIBSE, ASHRAE and HKIE

In 2005, CIBSE HK plan to organise more workshops on lift engineering and Albert So will continue his involvement.

8.0 CIBSE Guide D

Peer review of the guide is complete and the draft is with CIBSE for in-house editing and preparation for printing.

Anticipated publication date is September 2005.

The guide will be available at a reduced price for members of the CIBSE Lifts Group

9.0 Any Other Business

9.1 A question was tabled on the Lifts Group's liaison with other UK, European and indeed global institutions. It was felt opportunity might exist for the exchange of relevant information and ideas.

This opportunity will be investigated by the Group Committee who will report their findings.

9.2 A question was tabled from the floor regarding why BS5655 Parts 11 & 12 were being revised by BSI when BS EN81 Part 80 had just been published covering similar issues.

Dr Barney replied that the subject matter was different between Parts 11 & 12 of BS 5655 and Part 80 of EN81 and that the Treaty of Rome did not allow for the UK to publish Parts 11 & 12 under the banner of an EN81 document. Parts 11 & 12 had originally been published in 1989 and were overdue for review.

A further question was tabled as to whether the UK had adopted the timescales relating to the implementation of BS EN81-80. Dr Barney replied that the UK government had not adopted BS EN81-80 into law unlike some other European countries and there was no intention to do so. The UK approach to standards such as Part 80 was one of national filtering and site-specific risk assessment.
