BS EN81-1/2

Existing structure is under threat from Brussels who may wish to break it up into smaller sections each of which may be subject to local modification. UK position is to oppose this approach and support the continuing revision for the 2010 issue.

prEN81-40/41

Out for vote soon.

prEN81-21

Out for discussion.

PAS32-1/2

To be replaced by BS 8486-1/2 which are currently out for public comment – all comments due by end February 2007.
